

## **END USER LICENSE AGREEMENT ("EULA") FOR AskAdmin SOFTWARE**

**IMPORTANT - READ CAREFULLY:** This End User License Agreement is a legal agreement between you (either an individual or a single entity) and Sordum.org, which includes computer software and may include related media, printed materials, "online" or electronic documentation, and Internet-based services . Please read this agreement carefully. By purchasing, downloading, installing, distributing and/or using the Application, you agree to be bound by and comply with the terms and conditions set forth in this Agreement. Do not purchase, download, install, distribute and/or use the Application until you have read and accepted the terms and conditions set forth in this Agreement. An amendment or addendum to this EULA may accompany the Application.

**1. LICENSE GRANT.** Sordum.org grants you the rights described in this EULA provided that you comply with all the terms and conditions of this EULA. Sordum.org grants you a personal, limited, non-transferable, non-sublicenseable, non-assignable and revocable license to install and use the Application solely for your own personal use. Any future updates to the Application may contain an updated EULA. Please read the EULA carefully before purchasing, downloading, installing, distributing and/or using any Application updates.

**2. RESERVATION OF RIGHTS AND OWNERSHIP.** The Application is licensed as a single product. Its components may not be separated. The Application is protected by copyright and other intellectual property laws and treaties, and Sordum.org (or its affiliates, suppliers and/or their respective licensors, as applicable) owns all right, title and interest in and to the intellectual property rights in and to the Application, including, without limitation, all intellectual and proprietary rights appurtenant thereto, and, except for the limited license granted to you herein, nothing in this Agreement shall be construed as limiting, assigning, conveying, encumbering, altering, impairing or otherwise adversely affecting Sordum.org, its affiliates, suppliers and/or their respective licensors' ownership or proprietary rights therein, or any other information, processes, methods, products, goods, services or materials, tangible or intangible, of Sordum.org, its affiliates, suppliers and/or their licensors, in any form and in any medium. RESTRICTIONS.** You may not rent, lease, loan, share, publish, distribute, sell, redistribute, sublicense, or provide commercial hosting services with the Application, or make available any product license information or purchase transaction ID. You may not copy, clone, emulate, modify, decompile, reverse engineer, disassemble, attempt to derive the source code of, modify, or create derivative works of the Application, any updates or upgrades, or any portion thereof. You may not assign or otherwise transfer the Application or any of your rights hereunder to any party. Any

attempt to do so is a violation of the rights of Sordum.org, its affiliates, suppliers and licensors, as applicable. If you violate this restriction, you may be subject to criminal prosecution and damages. submit to the sole and exclusive jurisdiction of the courts of The Turkey or Germany located in the Europe Judicial District, and (c) to irrevocably consent to the exercise of personal jurisdiction by such courts and waive any right to plead, claim or assert that the Europe Judicial District is an inconvenient forum. No failure or delay by Sordum.org, its affiliates, suppliers or licensors to exercise any right or enforce any obligation shall impair or be construed as a waiver or continuing waiver of that or any other right or power. If any provision of this Agreement is found to be illegal, invalid or unenforceable, the remaining provisions of this Agreement will remain in full force and effect. You may not assign your rights under this Agreement without the prior written consent of Sordum.org, and any attempt by you to do so shall be void. Any provision of this Agreement that by its nature must survive termination of this Agreement in order to give effect to its intent shall survive such termination.

**12. TERMINATION.** This Agreement is effective until terminated by you or Sordum.org. In such event, you must cease all use of the Application and destroy all copies and components thereof.
